ACES is a public entity approved by the New Mexico Department of Finance and Administration (DFA) since 2013, to provide services and support to New Mexico schools.

- ACES operates through a Joint Powers Agreement (JPA)
- 97 Charter School Members out of 100 (membership is free)
- Assets shall be distributed to the current members in proportion to their contributions made to ACES
(Annual Shares Report)
- 26 Participating Entities – districts/government agencies
- Most funding is generated from administrative fees imposed on goods and services through cooperative purchasing contracts
