## Roofing Services

ACES has recently secured awards for construction management services and are pleased to announce an RFP active for Roofing



**Services.** This contract will encompass all roofing needs, including routine maintenance, repairs, and replacements. Selected contractors will be required to be knowledgeable about and comply with PSFA requirements and Statewide Adequacy Standards, among other conditions. Specifications also require quality assurance, testing and inspections, regular progress meetings, written updates, and a focus on ensuring agency operations continue without interruption. Interest in this solicitation has been strong, and we anticipate receiving several outstanding proposals. The submission deadline is currently set for January 13, 2026.

### **UPCOMING SOLICITATIONS**

ACES plans to kick off 2026 with a unique solicitation based on **Dual Language Program Development, Support and Educator Training**. The purpose of this solicitation is to facilitate contracting for services to assist schools with building or improving academic language and literacy programs for multilingual learners, with a focus on ensuring equity for culturally and linguistically diverse students.

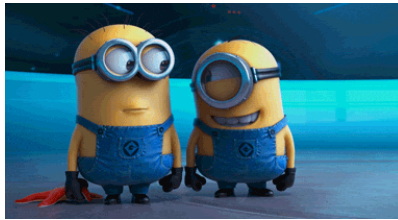
