ACES Strategic Planning -New Vision, Mission and Strategic Goals

"If you don't know where you are going, how will you know when you get there?

Recently the ACES Executive Board meet for a strategic planning session to examine and revise ACES' Vision, Mission, and Goals. Until now, ACES has not had a formalized Strategic Plan and was operating under an initial plan originally developed by Dr. Bruce Hegwer, ACES Executive Director, and Dr. Max Luft, ACES Deputy Director and CFO. The session, facilitated by Dr. Hugh Prather, focused on developing a Strategic Plan setting the direction and objectives of ACES for the next 3-5 years to help achieve the Vision and Mission articulated by the Executive Board.

Although not formally adopted by the ACES Executive Board yet, the new Vision for ACES is:

All needs met for charter schools' success.

The new Mission Statement for ACES is:

ACES provides efficient and effective "central support services" for charter school leaders empowering leaders to focus exclusively on educating students.

The Executive Board developed the following Goals to use as measurable targets for ACES for the next 3-5 years:

- The Association of Charter Schools Education Services will work directly with all charter schools to identify service needs, offer services to address those needs, and consistently monitor and strive to improve the quality of those services to charter schools.
- 2. The Association of Charter Schools Education Services will plan, develop, and implement a needs assessment process to ensure that all members have been able to identify both needs that are currently being met by ACES and unmet needs which ACES can address.
- 3. The Association of Charter Schools Education Services will plan and implement a process to build relationships with both like-minded and allied organizations such as the New Mexico Coalition of Charter Schools and Cooperative Educational Services to seek win/win solutions to charter schools' needs.
- 4. The Association of Charter Schools Education Services will develop and implement a marketing plan to make all charter schools aware of the range and scope of services provided by ACES.
- The Association of Charter Schools Education Services will utilize a variety of revenue sources including targeted grant funding and sound fiscal management to assure the sustainability of ACES.
- 6. The Association of Charter Schools Education Services will design and put in place an organizational structure that is transparent and contributes to the most effective delivery of

Now, we will develop objectives, activities and evaluation measures for each of the goals to ensure that progress is being made to meeting the objectives identified in the plan and that are aligned with our new Vision and Mission.
