## **CLIA Waiver Renewal Information**

The New Mexico Department of Health is encouraging NM schools to renew their CLIA Waiver certificates through the New Mexico Regional Education Cooperative-1 umbrella waiver program. The CLIA Waiver, which enables schools to administer on-site COVID, Influenza A&B, and pregnancy tests, will costs \$180 per campus through the State but it is provided free through the NMREC-1.
