Also, if the contract should be sent to someone other than you for signature, please let us know.

Feel free to utilize the contract for marketing security services to public agencies anywhere in New Mexico. If they are not already an ACES member (participating agency), just refer them to me to get them established. Quotes for desired services shall be provided to the participating agency based on the individual scope of work desired or otherwise negotiated at the rates set forth under this contract as applicable. Purchase orders (POs) will be issued to you by ACES once a PO is received from the participating agency referencing you as the contractor and RFP #24-04. **Please note that no services shall be provided to any participating agency until a purchase order is issued to you by ACES on behalf of that agency.** In addition, all invoices shall reference the corresponding ACES PO # for correct routing. Just as a reminder, per the contract terms when ACES issues payment to you 1.5% of the total invoice amount will be withheld for our admin. Fee. All invoices shall have that fee either embedded in your hourly rate or in the total overall cost of services quoted.
